

## **PROVISIONS FOR SPES SUMMER ACCOMMODATION 2024**

SPES offers 4 double room accommodations for foreign students already awarded SPES housing for the academic year 2023-2024.

The summer stay period in the residences is from 01/08/2024 to 02/09/2024.

To request summer accommodation, you must meet all the following requirements:

- Be a winner of the SPES housing call for the A.Y. 2023-2024 already housed in the Residences.
- Have earned at least 15 credits by the application submission date (only credits regularly registered in the online university record book for the academic year 2023/2024 will be considered);
- Justify your request when filling out the application form (attending internships, even if not mandatory, preparing and/or taking exams, writing a thesis, and/or proven inability to return to your home country).

The stay in accommodation is subject to a fee at a flat rate of €250.00 per person for a double room and €350.00 for a single room; fees must be paid before entering the summer accommodation by bank transfer. A copy of the bank transfer must be sent before entry.

### **Allocation Criteria**

The accommodations are assigned, within the limits of the available places mentioned above, according to the following priorities:

1. Seniority of enrollment year at the University of Genoa;
2. Number of credits earned;
3. Distance from the home country.

### **Application Submission**

Students must apply for summer accommodation by sending an email to [segreteria@spes-savona.it](mailto:segreteria@spes-savona.it), accompanied by documentation and reasons for requesting the stay for the month of August. Applications can be sent from June 10, 2024, at 8:00 a.m. until June 30, 2024, at 12:00 p.m.

Each application must necessarily be accompanied by the following documentation (in PDF format):

- Self-certification of exams passed using the form downloadable exclusively from Sportello Unige;
- Possible internship registration certified by the University of Genoa.

In the absence of one or more of the above documents, the application will not be considered valid and the benefit will not be granted.

### **Communication Method**

All communications, including any ranking updates, will be sent to the email address provided by the student. These communications are legally binding even if the email address is incorrect.

### **Further Grounds for Exclusion**

Applications cannot be submitted by:

- Students who are in debt to SPES and have not regularized their position;

- Students who have faced disciplinary sanctions.

### **Publication of Results**

The list of admitted students will be published, unless force majeure, by July 10, 2024, on the website [www.spes-savona.it](http://www.spes-savona.it).

Students who, after the publication of the ranking, intend to withdraw must notify by emailing [segreteria@spes-savona.it](mailto:segreteria@spes-savona.it) by July 17, 12:00 p.m. to avoid payment. Withdrawal requests received after this date will not be considered valid and the fee must still be paid.

It should be noted that any outstanding debts will also be considered for potential participation in the 2024/2025 benefits competition.

### **Use of Accommodation**

The stay in student residences during the summer period is always regulated according to the regulations.

Apartments must be returned in perfect condition, both in cleanliness and furnishings. Any shortcomings will be charged and may preclude access to the new 2024/2025 call.

In case of inadequate cleaning conditions, a fee of €50.00 will be charged for cleaning expenses, unless the conditions require more work, which will be quantified later.

Upon entry, the student accepts and is aware that during the Campus closure weeks, no maintenance and/or repairs (except emergencies) can be carried out, and no compensation will be claimed.

### **Move**

On August 1st, the student must leave the previous accommodation completely free of personal items, including common areas, refrigerators, and pantry.

SPES will deliver the keys to the new accommodation only after verifying the conditions of the previous accommodation. If damage and/or inadequate cleaning conditions of the previous accommodation are found, the new assignment cannot be made, and the student will be considered "Not Eligible" and must find new accommodation, as the check-in cannot be rescheduled.
